- 1. New Article Ninth is added, as follows: "NINTH. corporation is dissolved, the corporation's property shall be distributed in such shares as the Board may in its sole discretion then determine to one or more organizations (a "Qualified Organization") described in Sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986, or the corresponding provisions of any subsequent federal tax laws, or to the federal, state or local government for exclusive public use; provided that, if St. Michael's Independent School, Stuart, Florida, or its successor, is a Qualified Organization, it shall receive one-half of the corporation's property; and if St. Mark's Episcopal School, Palm Beach Gardens, Florida, or its successor, is a Qualified Organization, it shall receive one-half of the corporation's property."






