The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Not For Profit corporation for profit under Chapter 617 of the Florida Statutes.

ARTICLE I. NAME

The name of the corporation is HARVEST FAMILY OUTREACH, INC.

ARTICLE II. ADDRESS OF PRINCIPAL OFFICE
