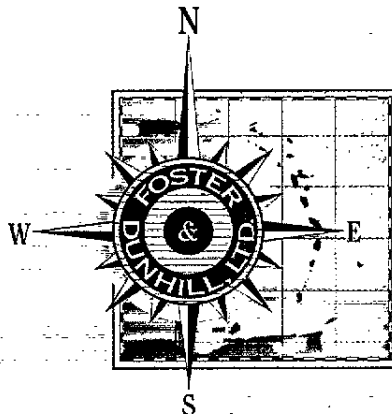

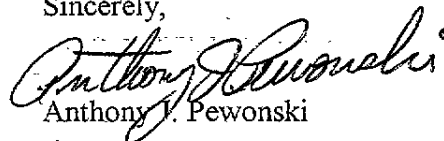

### ARTICLE III      PURPOSES

The specific purpose for which this corporation is organized is:

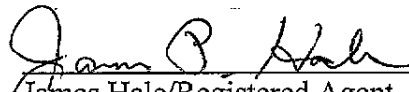
