ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLES I: NAME

The name of the corporation shall be:

Turkey Creek High School Alumni and Friends Association Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III: PURPOSES

The specific purposes for which the corporation is organized are:

1. To maintain organized contact between its alumni, former faculty and the community.
2. To promote involvement of alumni in Turkey Creek Middle School for the purpose of facilitating excellence in education for future generations.
3. To foster a spirit of fraternity among graduates and former students of Turkey Creek High School and Turkey Creek Middle School.
4. To encourage recreational activities for its members and promote other appropriate non-profit activities.

6. To act on behalf of Turkey Creek Middle School for the purpose of raising funds for scholarships, school improvements or other endeavors beneficial to the schools and students.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

1. **Report of the nominating committee**
 - a. The report shall be published in the call to meeting to appear no later than fifteen (15) days prior to the general meeting and shall be read at the meeting by the committee.
