## ARTICLES OF INCORPORATION OF 21ST CENTURY MINISTRIES, INCORPORATED

SEREN PARA PARA 10

The undersigned natural person, having capacity to contract and acting as the incorporator of a nonprofit corporation under Chapter 617 of Florida Statutes known as the "Florida Not-For-Profit Corporation Act" (the "Act"), adopts the following Articles of Incorporation for such corporation:

- 1. The name of the corporation is 21st Century Ministries, Incorporated.
- 2. The principal place of business and complete mailing address of the corporation shall be:

21st Century Ministries, Incorporated c/o First Presbyterian Church 106 East Church Street Orlando, Florida 32801

- 3. The purposes for which the corporation is organized are:
  - (a) To bring the Light of Jesus Christ into the world by engaging in (i) the acquisition, development, creation, production and distribution of sacred and secular media that have an uplifting, inspirational and life affirming message; and high artistic and technical values; (ii) the support through financial contributions of other similar efforts; and (iii) any act or activity which would lead people toward an understanding of the values of the Christian life.
  - (b) To operate exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code"), or any corresponding provision adopted in the future; and
  - (c) Within the aforesaid limitations, to have and exercise all of the powers as are permitted for a corporation not for profit under the Act.

4. The corporation shall have no less than three (3) directors and the manner in which any additional or successor directors shall be elected is by an affirmative vote by the majority of the directors then in office. The initial Board of Directors shall be as follows:

In the event of the dissolution or liquidation of the corporation, the residual assets of the organization shall be turned over to one or more religious organizations which themselves are organizations described in Sections 501(c)(3) and 170(c)(2) of the Code, or to the federal, state or local government (or to any political subdivision thereof) for exclusively public purposes as the Board of Directors shall determine in accordance with the Act.
- 8. No part of the assets or income of this corporation shall inure to the benefit of any private shareholder or individual, and no part of the activities of this corporation shall

To the extent that these sections would otherwise apply, the corporation shall distribute its income for each taxable year at such time and in such manner as not to subject the corporation to tax under Section 4942 of the Code, and the corporation shall not engage in any act of self-dealing as defined in Section 4941 of the Code, retain any excess business holdings as defined Section 4943 of the Code, make any investments in such manner as to subject the corporation to tax under Section 4944 of the Code or make any taxable expenditures as defined in Section 4945 of the Code. - No director or advisory board member shall have any personal liability to the 10. corporation for monetary damages for breach of fiduciary duty as a director or advisory board member, provided that this paragraph shall not eliminate or limit the liability of a director or advisory board member (a) for any breach of the director's or advisory board member's duty of loyalty to the corporation; (b) for any acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; or (c) liability for unlawful distributions from the corporation under the Act, as amended, from time to time.
