ARTICLES OF INCORPORATION OF
TOP GUN SUPERSTARS CLUB, INC.

[A Florida Not for Profit Corporation]

BE IT KNOWN, that on this 9th day of February, 1998, the undersigned incorporator, Mike Hudson, for the purpose of organizing a non-profit corporation under the Florida Not for Profit Corporation Act hereby adopts the following Articles of Incorporation:

I.

The name of the corporation is Top Gun Superstars Club, Inc.

II.

The principal place of business and mailing address of this corporation shall be:

5620 E Fowler Avenue; Suite D
Tampa, FL 33617.

III.

The purpose of the organization is to work for and to promote the fraternity, unity, brotherhood, and social spirit of persons engaged in the mutual pursuit of pleasure, recreation and happiness through a career in sales. Corporate undertakings shall under no circumstances include any activities not permitted by organizations organized under Internal Revenue Code §501(c)(7).

IV.

The direction and administration of this corporation shall be vested in a Board of Trustees, the number of Trustees and their terms of office to be prescribed by the By-Laws of the corporation. The Trustees shall be elected by the membership as prescribed by the By-Laws; however, any vacancy on the Board of Trustees may be filled by the majority vote of the remaining members.

V.

The duration of the corporation is not limited.

VIII.

The corporation is organized on a membership basis. There shall be no stock authorized or issued. The types of membership, qualifications and rights of members shall be as prescribed in the By-Laws of the corporation.

IX.

These Articles and By-Laws may be amended by a two-thirds vote of the membership present at any given meeting, provided that the membership be notified of the proposed change at least ten days prior to the meeting wherein the proposal is submitted for a vote.

X.

The officers of the corporation shall be elected as provided in the By-Laws.

XI.

The corporation is a non-profit corporation within the intent and meaning of the Florida Not for Profit Corporation Act.
