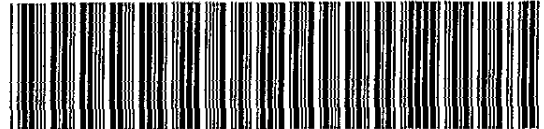



Article I: The name of the Corporation New Dimensions Family Services, Inc. is **amended to the name, Rizpah Family Services, Inc.**


