ARTICLES OF INCORPORATION

OF

THE PURE GOLD ELVIS PRESLEY FAN CLUB OF SOUTH FLORIDA, INC.

The undersigned subscribers to these Articles of Incorporation are natural persons competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **THE PURE GOLD ELVIS PRESLEY FAN CLUB OF SOUTH FLORIDA**, **INC.**, (hereinafter, "Corporation).

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida as a fan club.

ARTICLE 3 - PRINCIPAL OFFICE

ARTICLE 7 - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE 8 - CAPITAL STOCK

This Corporation shall have no capital stock and shall be composed of members rather than shareholders.

<u> ARTICLE 9 - QUALIFICATIONS OF MEMBERSHIP</u>

ARTICLE 10 - VOTING RIGHTS

Members of the Corporation will have such voting rights as are provided in the By Laws of the Corporation.

ARTICLE 11 - LIABILITIES FOR DEBTS

Neither the members nor the members of the Board of Directors or officers of the Corporation shall be liable for the debts of the Corporation.
