ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, for the purpose of forming a not-for-profit corporation under Florida Statutes Chapter 617, hereby adopts the following articles of incorporation

ARTICLE I - NAME

The name of the corporation shall be Church of God Family Worship Center Inc.

ARTICLE II - PURPOSE

The corporation is organized for the specific purpose of operating a Christian Church, a place to gather for worship, and prayer on Sundays and during the week. It is also organized to conduct activities as it is called upon to serve its mission.

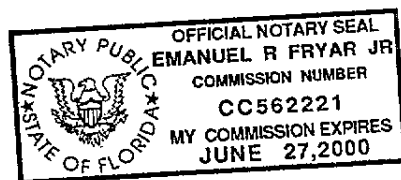
