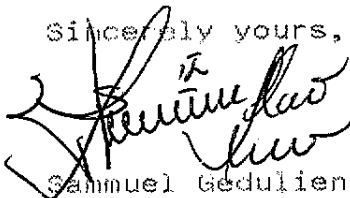

# ARTICLE OF INCORPORATION

OF

CHRIST FOR ALL MINISTRIES, INC.

We the UNDERSIGNED, natural persons of legal age acting as incorporators, do hereby associate ourselves together to become incorporated under Chapter 617 of the Florida Statutes applicable to not-for-profit corporations and adopt the following Article of Incorporation:

## ARTICLE I - NAME

The name of the corporation is CHRIST FOR ALL MINISTRIES, INC.

## ARTICLE II - DURATION

The period of its duration is perpetual.

## ARTICLE III - NATURE OF BUSINESS

The purpose(s) for this corporation is organized are: "To operator a NOT-FOR-PROFIT CHRISTIAN MINISTRY ORGANIZATION, and to associate together with persons, associations, corporations, inter-denominational organization dedicated to ministering through evangelism and compassionate actions, and to address the needs of Haitian communities in the United States and Haiti as to promoting Christianity". "And any other lawful business activity for which not-for-profit corporation may be incorporated under Chapter 617 of the Florida Statutes, and within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, and or corresponding provisions of any Revisions and future United States Internal Revenue Law".

## ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are qualified, elected or appointed is as follow; Each year at its General annual meeting, the members of the corporation shall elect a board of directors to serve for the ensuing year as provided for in the by-law.

## ARTICLE V - REGULATION OF INTERNAL AFFAIRS

The Internal affairs of the corporation are governed by the "BY-LAWS" which shall be establish and approve by a majority of the directors at the first meeting of the Board of Directors.

## ARTICLE VI - LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes. There are no provisions limiting the powers of the corporation except as prohibited by section 617.0833.

## ARTICLE VII- REGISTERED OFFICE, AGENT AND MAILING ADDRESS


Section 1. The address of the initial registered office of the corporation is 11856 Hullbridge Ct., Orlando, Florida 32837 and its initial Registered Resident Agent at such address is Samuel Gedulien.

Section 2. The Principal Place of Business: The Principal meeting place is 11856 Hullbridge Ct., Orlando, Florida 32837.

#### ARTICLE VIII-- INCORPORATORS

WE, THE UNDERSIGNED, for the purpose of forming a not-for-profit corporation under the Laws of the State of Florida do make, file, and record this certificate of Article of Incorporation and do certify that the facts herein stated are true; and we have accordingly hereunto set our hand this 13th day of January 1998.

#### ARTICLE IX - BOARD OF DIRECTORS

Section 1. This corporation shall be operated and governed by a Board of Directors. The by-laws may provide another name for the Board of Director and otherwise provide for the extent and limit of their powers, duties and privileges, and further, shall provide the manner of appointment, qualification or election and other matters relating thereto, subject to restrictions herein, including:

- a. The number of directors may be provided in the by-laws but shall at all times not less than three (3);
- b. The Board of Directors have power to make, alter, or rescind all such by-laws and regulations to rule the business of the corporation as will not be inconsistent with these Articles, or the laws of the State of Florida. All such change must be ratified by two thirds (2/3) of the membership of the corporation.

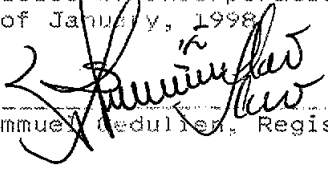

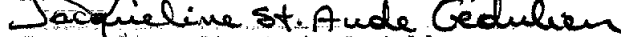

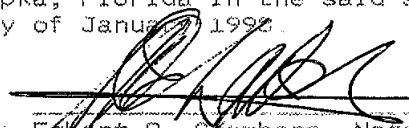
