

ARTICLES OF INCORPORATION
OF
DOT RICHARDSON SOFTBALL ASSOCIATION OF ALTAMONTE SPRINGS, INC.
A NONPROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:

DOT RICHARDSON SOFTBALL ASSOCIATION OF ALTAMONTE SPRINGS, INC.
The address of the principal office of this corporation shall be 230 Crown Oak Centre Drive, Longwood, Florida 32750, and the mailing address of the corporation shall be the same.

ARTICLE II.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to promote play of women's fast-pitch softball for youths ages 5-18.


