ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: THE BREATH OF LIFE APOSTOLIC CHURCH, INCORPORATED.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address shall be: 1905 W. BOBE STREET, PENSACOLA, FL 32501.

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are: To promote the Apostolic Faith as taught by the Apostles of the Lord Jesus Christ; to provide spiritual, moral, and financial support and guidance to its membership, and all others who desire such support; to acquire, construct, hold, sell, and convey property, both real and personal for the general and special purposes of the corporation; to receive, hold, and use gifts or bequests of money or property for any general or special religious, benevolent, charitable, educational, social, or other purpose, enterprise, or project connected with the corporation, and may receive such gifts or bequests to be invested, in whole or in part. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable, or desirable for the furtherance of the corporate objectives expressed above.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which directors are elected or appointed is as stated in the bylaws.
