Article 5. Initial Registered Agent and Office. The initial registered agent is Freddie Mae Livingston, and the initial registered office 701 Southwest 1st Ave., Micanopy FL 32667.

Article 6. Board of Directors. The initial Board of Directors shall have five members whose names and addresses are: The same persons listed as initial members in Article 4.

Directors shall be elected at the first meeting of the calendar year or at the annual meeting of this organization, by a plurality of the members present at such meeting, provided that more than one-half of the members are present. Officers shall thereupon be chosen by the directors.

Article 7. Officers. The officers of the Corporation shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as maybe prescribed by the Bylaws. ARTICLES OF INCORPORATION

A FLORIDA NONPROFIT CORPORATION

Article 1. Name. The name of the Corporation is: Micanopy Outreach Fellowship, a Florida non-profit corporation.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purpose of the corporation is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to serve the community with a building open to local citizens to hold public meetings, social and special functions, religious-related services, senior citizens, children's groups. The corporation shall not discriminate based on race, religion, sex, or ethnic origin.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. Article 8. Incorporators. The names and addresses of the incorporators of this corporation are: Freddie Mae Livingston, Freddie L. Robinson and Adams C. Myers.

Article 9. Nonstock Basis. The Corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the bylaws.

Article 10. Corporate Address. The street address of the Corporation's initial principal office is 701 Southwest 1st Avenue, Micanopy FL 32667; and, if different, the Corporation's mailing address is Postal Box 181, Micanopy FL 32667.

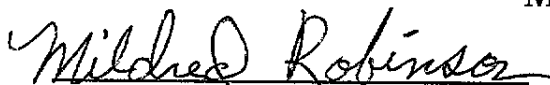
