The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation non profit in accordance with the Laws of the State of Florida.

ARTICLE ONE - NAME

The name of the corporation is TEMLE ZION, INC.

ARTICLE TWO - PURPOSE

The corporation is organized for the purpose of proviting religious orintation, worship services, bible studies and all activities related to church ministry. To organize, operate, and will maintain a center in the community of Boca Raton, Florida and any place or activities the State will allow.

ARTICLE THREE - ADDRESS OF CORPORATION

The principal office and the mailing address of the corporation shall be 624 NW 13 St Suite 13, Boca Raton, Florida 33486.

ARTICLE FOUR - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE FIVE - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE SIX - BOARD OF DIRECTORS

The Board of Directors of this corporation shall consist of not less than three nor more than seven members, the exact number of directors to be fixed from time to time by the directors or by the by-laws. The church and the affairs of this corporation shall be managed by the Board of Directors, which may exercise all such powers of this corporation and do all such lawful acts and things as are not by law directed or required to be exercised or done only by the directors. Subject to the by-laws of this corporation, meetings of the directors may be held within or without the State of Florida. The Directors of this corporation may remove any directors from office at any time with or without cause. ARTICLE SEVEN - INCORPORATOR

The name and address of the incorporator making these Articles of Incorporation is Lorena Mercado, 624 NW 13 St Suite 13 Boca Raton, Florida 33486.

ARTICLE EIGHT - BY-LAWS

The power to adopt the by laws of this corporation, to alter, to amend or repeal the by-laws, or to adopt new by-laws shall be vested in the Board of Directors of this corporation, provided however, that any by-law or amendment thereto as adopted by the Board of Directors may be altered, amended or repealed by the vote of the members entitled to vote thereon, or a new by-law in lieu thereof may be adopted by a vote of the members.

The by-laws of this corporation shall be for the government of this corporation and may contain any provisions or requirements for the management and conduct of the business of this corporation, provided the same are not inconsistent or contrary to the laws of the State of Florida or of the United States.

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
