ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be **SUBURBAN MEDICAL CENTER, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 17615 S.W. 97 Avenue (U.S. 1 and Franjo Road), Miami, Florida 33157.

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is to provide counseling and mental health services and to engage in all other lawful acts or activities not for pecuniary profit for which Florida not for profit corporations may be organized.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS


The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than two directors. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but may never be less than two. The election of directors shall be done in accordance with the Bylaws. The directors shall be protected from personal liability to the fullest extent permitted by law.

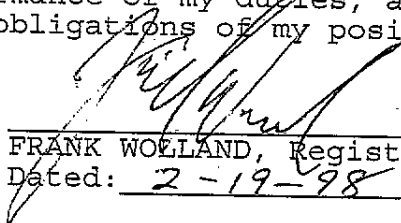
