ARTICLES OF INCORPORATION  
OF  
JAVIER MORIN-RODRIGUEZ MINISTRY, INC.

A NON-PROFIT CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA

These Articles of Incorporation entered into this 2nd day of February, 1998, by and between Pastor Javier Morin-Rodriguez, Mrs. Christina Hancock-Morin, Pastor Vincente Valedon, Pastor Hernan Barrera, Pastor Jose Victor Dugand, Mrs. Michelle Barrera, Mrs. Jessica Dugand, and their associates, do hereby associate themselves together as a body corporate, not for profit, pursuant to Chapter 617 of the Florida Statutes and all the Amendments thereto, and do adopt, as their proposed Charter, the following, to wit:

ARTICLE I

The name of the corporation shall be Javier Morin-Rodriguez Ministry, Inc.

ARTICLE II

ARTICLE III

The general nature and purpose of the corporation shall be as follows, to-wit:

a) To promulgate, assist and further the cause of Christianity and to teach the ideas and ideals of Christianity conducting of concerts, seminars, any method of broadcasting and networking. Thru the productions of cassettes, compact disc, video cassettes, records, t-shirts, books, brouchers, and ect., containing christian & family value music & promoting christianity and family values messages. To perform other religious functions associated with the goals of the organization expressed herein.

b) To engender and develop amongst its members and with whomsoever they come into contact, the highest principles of the moral, ethical and religious aspects of Christianity.

c) To acquire, through lease or purchase or otherwise, sites for activities interrelated to the purpose of the Corporation.

d) To purchase, take, hold, lease, rent, sell or mortgage, real property for any purpose whatsoever which would promote the purposes of the Corporation.

e) To purchase, take, hold, lease, rent, sell or mortgage, personal property and do all things incidental or necessary or convenient in order to carry out the express purposes and ideals and goals of the Corporation.

f) To solicit and collect voluntary contributions for the purposes of advancing the work of the Corporation and for the purposes of employing such religious personnel as

g) To do everything lawful and necessary to accomplish the foregoing purposes and goals.

#### ARTICLE IV

The manner in which the directors are elected or appointed is stated in the By-Laws of this Corporation.

The affairs of this Corporation shall be managed by a Board of Directors consisting of the incorporators hereinafter subscribed, who shall annually be elected and installed to the following offices, to-wit:

Membership shall be by application to the Corporation, setting forth the applications qualifications and their admission and retention shall be approved or disapproved by the membership at large in a manner as provided for in the By-Laws of the Corporation.






