ARTICLES OF INCORPORATION

ON, INESSERVE AMIL. 40 ASSOCIATION OF INDEPENDENT REPRESENTATIVES FOR EDUCATION, I A NOT FOR PROFIT CORPORATION

I, Nicholas Willocks, the undersigned natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a not for profit corporation under the laws of the State of Florida as contained in CHAPTER 617.0202, F.S., entitled "Not for Profit Corporation Act." and the general amendments thereto, do hereby set forth:

ARTICLE 1.

The name of the corporation is Association of Independent Representatives for Education, Inc.

ARTICLE 2.

The corporation is a educational corporation located at 112 W. Pine Ave., Longwood FL 32750.

ARTICLE 3.

The purposes for which the corporation is organized are:

Education of wholesale sales personnel, counter personnel and contractors.

The purpose for which Association of Independent Representatives for Education, Inc. is organized are exclusively educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication of distribution of statements), any political campaign on behalf of any candidate for public office.

The corporation shall have members which may be divided into such classes as shall be provided in the bylaws. All members shall be accepted, appointed, elected or designated in the manner provided in the bylaws.

ARTICLE 4.

The directors of the corporation shall be elected or appointed in the manner and for the terms provided in the Bylaws. No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the corporation; and upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of al the liabilities of the corporation, dispose of the residual assets of the corporation exclusively for the stated purpose of the corporation in such manner, or to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any future Internal Revenue Code. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, for such purposes or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
