Consider this letter as notification of the Department of State's notice of intent to administratively dissolve/revoke NEW LIFE INDEPENDENT CHURCH CORP., for failure to maintain a registered agent as required by section 617.0502, Florida Statutes. This business entity will be dissolved/revoked on or after March 23, 2010 unless a registered office or registered agent address change is made that complies with Florida Statutes.

The 2010 Annual Report is now due and you can make the required registered agent change plus any other additions or deletions for your non-profit corporation when you file the 2010 Annual Report with the filing fee of \$61.25 from our website at www.sunbiz.org. As an option I have also enclosed a "Statement of Change of Registered Office or Registered Agent or Both for Corporations" form which you can fill out and mail back to the Division of Corporations to my attention with the filing fee of \$35.00. Please note by filing the required 2010 Annual Report from our website and making the registered agent change you will save paying an additional \$35.00 fee.

I sent you a letter on January 12, 2010, informing you that the corporation listed above would be administratively dissolved if you did not designate a new Registered Agent in Florida. You listed S. Anderson as registered agent with 5715 Will Clayton #7724 in Ft. Lauderdale, FL as the address. This address does not exist. The street address is the same as the principal address of the corporation in Humble Texas but you have listed Ft. Lauderdale, FL as the city and state for the registered agent. Service of Process obviously cannot be served on S. Anderson at that address and you have not responded to my letter or designated a new Registered Agent to correct this error. You have since filed an annual report on April 16th and did not correct the error. You must contact me by Friday, October 8th or your corporation will be administratively dissolved. This is one last attempt to notify you.
