ARTICLES OF INCORPORATION

OF

TRUE GOSPEL PENTECOSTAL CHURCH, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Corporation, Act., does hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the Corporation is **TRUE GOSPEL PENTECOSTAL CHURCH, INC.** and the principal place of business is 4327 W. Columbia Street, Orlando, Florida 32805.

ARTICLE II

This corporation is a nonprofit religious corporation.

ARTICLE III Authorization

This corporation shall proceed under Chapter 617 of the Florida Statutes, of the laws of the State of Florida.

ARTICLE IV Purpose

societies; to acquire money, securities land, or buildings and hold the same, and to invest or reinvest the same or the income therefrom for the general charitable and religious purposes as set out herein. To promote the teaching of the gospel, ministerial and general education, the establishment, maintenance and assistance of the **TRUE GOSPEL PENTECOSTAL CHURCH, INC.**, and its missions and Bible schools; to provide care for worthy pastors, their wives, widows, and dependent children; to advance the belief of its constituency on moral, religious, and denominational matters; to promote denominational unity and efficiency in efforts for the evangelization of the world.

ARTICLE V

Duration

The period of duration of this corporation is perpetual.

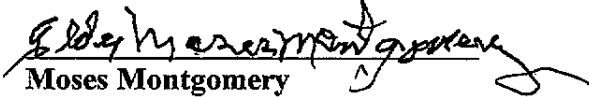

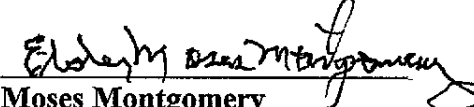
