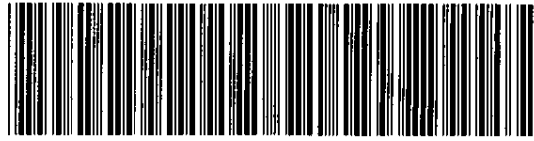

**ARTICLES OF INCORPORATION**  
**OF**

We the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporation not-for-profit, under the following proposed charter:

**ARTICLE I. NAME**

The name of the corporation shall be TRUE GOSPEL PENTECOSTAL COMMUNITY CHURCH, INC. and shall be located at 4327 W. Columbia Street, Orlando, Florida 32811.

**ARTICLE II. PURPOSES**

It is the desire of the True Gospel Pentecostal Community Church, Inc. to be an outreach ministry to the community and to those in spiritual need. To receive Christ into their being as the only means by which they can be saved from the guilt of sin and to escape the wrath of God in the last days, thereby calling persons to active discipleship in the church community.

**ARTICLE III. MEMBERSHIP**

The persons forming this corporation and those hereafter admitted to such membership shall constitute the membership of this corporation. Any person who is a member of the church is called a *disciple of Christ* and is expected to participate in and to contribute to the purpose of this corporation.
