## ARTICLES OF INCORPORATION

### ATTACHMENTS

#### ARTICLE III -- PURPOSES

The purposes for which the corporation is organized are exclusively for charitable, religious, and educational purposes. Including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law).

No part of the net earnings of the corporation inures to the benefit of, or is distributable to, its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes as set forth in this Article. No substantial part of the activities of the corporation shall be carrying on of propaganda or otherwise attempting to influence Legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 ( or the corresponding provision of any future United States Internal Revenue law), or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 ( or the corresponding provision of any future United States Internal Revenue law).
