#### ARTICLES OF INCORPORATION

## ARTICLE I. NAME

The name of this corporation is HERITAGE BIBLE CHURCH OF PALM BAY, INC.

#### ARTICLE II. DURATION

This corporation shall have perpetual existence.

#### ARTICLE III. PURPOSE

- 5.
