**Articles of Incorporation of:**

A Nonprofit Corporation

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

**ARTICLE 1**

The name of the corporation shall be:

**ARTICLE 2**

**ARTICLE 3**

The purposes for which this corporation is organized are:

To establish a church of the Christian Faith open to the general public in order to foster religious belief in the authenticity of Jesus Christ as God and Savior, and the Holy Bible as the inspired, inerrant Word of God. The corporation operating as a church will conduct meetings, Bible study groups, visitation, evangelistic programs, public rallies, and religious publishing for the purpose of promoting the Judeo-Christian Faith.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

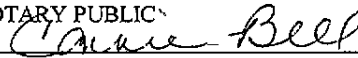

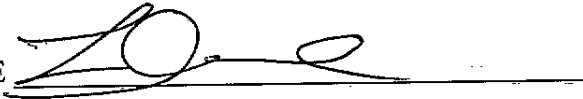
