**Articles of Incorporation
Of

(A NON-PROFIT ORGANIZATION)**

By the Articles of Incorporation, the incorporator forms a corporation not for profit under Florida law, chapter 617.

Article I Name & ADDRESS

The name of this corporation is Missionary Homes Evangelistical Association, Inc. Whose principal address is 852 Saxon Blvd., #29, unit 348, Orange City, FL. 32763

Article II Term

This corporation shall exist perpetually.

Article III Purpose

The purpose of this corporation is to ASSIST, AID and provide housing to ministers and affordable housing to others in need.

Article IV Non-Profit Status

Section 1. No part of the earnings, if any, of the corporation will benefit anyone individual or member of the corporation.

Section 2. The corporation shall refrain from, or act as, a political group bent on legislation or the promotion of political candidates.

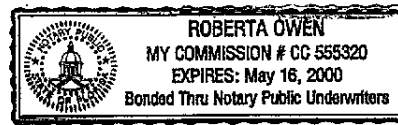
