The undersigned incorporator(s) for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

Article I-Name of the Corporation

Article II-Nature or Purpose of the Business

The purpose of the corporation is to engage in any lawful activity permitted by the laws of this state. This corporation is being established to manage the resources needed to organize the Raford and Phelp families during their annual gathering. This corporation shall function as a non-profit corporation in accordance with Florida statutes, and shall submit a 1023 application for 501(c) (3) tax exemption in the very near future.
