We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be LIFESKILLS OF PASCO, INC., with it's principal office at 4038 Fairford Drive, New Port Richey, Pasco County, Florida 34652.

ARTICLE II

PURPOSE

The purpose of this corporation not for profit is exclusively religious, charitable, and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE III

QUALIFICATIONS FOR MEMBERSHIP

The qualification of members and the manner of their admission shall be as stated in Article V of the Bylaws of this corporation.

ARTICLE IV

TERM

This corporation shall exist perpetually beginning on the 23rd day of February, 1998.

ARTICLE V

NAME OF SUBSCRIBERS

ARTICLE VI

BOARD OF DIRECTORS

This corporation shall have a Board of Directors of not less than three (3) members nor more than nine (9) members. The number of directors shall be prescribed in the By-Laws of the corporation, which Board shall meet annually as provided in the By-laws or, on the call of the chairman, and shall prescribe the basic policies under which the corporation shall operate. The Directors shall be elected by the membership at its annual meeting.

ARTICLE VIII

BY-LAWS

The By-Laws of the corporation shall be adopted and amended by the Board of Directors.

ARTICLE IX

AMENDMENTS TO ARTICLES OF INCORPORATION

These Articles of Incorporation may be altered, changed, or amended by two-thirds (2/3) vote of the Directors present at any regular business meeting called for that purpose, provided that proper notice has been given at a previous regular business meeting.

Amendments to the Articles of Incorporation, when approved by the Board of Directors, must also be forwarded to the Secretary of State of Florida and filed and approved by him before the same shall become effective.

ARTICLE X

RESIDENT AGENT

The initial Resident Agent for the corporation shall be Jacqueline Williams, 6963 Bottle Brush, Port Richey, Florida 34668.

ARTICLE XI

DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt or organizations described in Sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or local government for exclusive public purpose.

ARTICLE XII

POWERS

Notwithstanding any other provisions of these Articles or the bylaws, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law.
