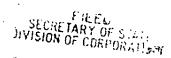

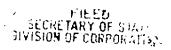

EXHIBIT "A"

ARTICLE II, SECTION 5 SHALL BE DELETED AND ADDED AS FOLLOWS:

Section 5. In addition to the powers and purposes as further enumerated under this Article II, Sections 1-4, the Association shall have all of the rights, powers, duties and functions of a State of Florida Condominium as governed by the law and Declaration of a Multi-Condominium Association and shall govern and administrate the affairs of Parker Lakes One, A Condominium and of Parker Lakes Two, A Condominium, and shall supersede and assume the obligations of each of their respective Condominium Associations which have been merged into this corporation. As a Multi-Condominium Association, it shall be governed by Chapter 617 and Chapter 718, as its rights, duties and obligations are enumerated and in accordance with the respective condominiums for which it governs and these Articles of Incorporation and Bylaws.

This corporation—shall prepare—and maintain separate books and—records and budgets for each of the respective condominiums that it governs and administrates, and shall maintain—separate books and—records and financial statements—for each of the respective—condominiums that—it—governs. The Corporation shall prepare and maintain only one set of books and records and budget and financial statements for the condominium.
