**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
THE NEXT STEP ADOLESCENT AND YOUTH COMMUNITY CENTER, INC.**

Pursuant to the Florida Not-For-Profit Corporation Act, Article IX of the Articles of Incorporation of The Next Step Adolescent and Youth Community Center, Inc., a Florida not-for-profit corporation, hereinafter referred to as the "Corporation," is amended to delete from the eighth and ninth lines of Article IX the words "Sections 501(c)(3) or (c)(4)" and replace them with the words "Section 501(c)(3)."

This Amendment shall be effective as of the date of filing.

The foregoing Amendment to the Articles of Incorporation of the Corporation was proposed and approved unanimously by the Corporation's Board of Directors on April 7, 1999, pursuant to Section 617.1002 of the Florida Not-For-Profit Corporation Act. The Corporation has no members.
