ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida 49 Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation: SECRETARY OF STATE TAIL AHASSEE, FLORIDA

ARTICLE I NAME

The name of the corporation shall be: WORLDWIDE FINANCIAL EDUCATION FOUNDATION, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 3001 Alamo Avenue, Suite 225, Winter Park, Florida 32792

ARTICLE III PURPOSE

The specific purposes for which the corporation is organized is for educational purposes, specifically to educate individuals in the area of global financial management and investments. These purposes include the making of distributions to other educational organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal code.

ARTICLE IV MEMBERS

The Corporation shall have members whose membership shall be evidenced by a certificate or certificates of membership representing their membership in the corporation.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is stated in the bylaws of the corporation.

ARTICLE IX EARNINGS NOT TO BE DISTRIBUTED

No part of the earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of the purposes set forth in ARTICLE III hereof. No substantial part of the activities of the Corporation shall be the carrying of propaganda, or otherwise, attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, of (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE X DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of Corresponding Revision of any future federal tax code., or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XI INTERNAL AFFAIRS

Regulation of the internal affairs of the Corporation shall be provided in the Corporate Bylaws.
