**ARTICLES OF INCORPORATION
OF
THE UNIVISION OUTREACH MINISTRIES, INCORPORATED**

We, the undersigned, hereby associate ourselves for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, and respectfully petition the Secretary of the State for approval of such incorporation under the following proposed ARTICLES OF INCORPORATION:

**ARTICLE 1 - NAME
THE**

The name of the Corporation shall be: **UNIVISION OUTREACH MINISTRIES,
INCORPORATED**

ARTICLE 2 - PRINCIPLE PLACE OF BUSINESS AND WORSHIP

The principal place of business and worship shall be at 2682 Clearbrook Circle, in the city of Orlando, county of Orange and State of Florida. The Corporation shall designate a registered office in accordance with Florida law and shall maintain it continuously. The Corporation may have offices at such other places within and without the State of Florida as the Board of Directors may from time to time determine.

ARTICLE 3 - PURPOSE

A. This corporation is a non-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation are:

1. Provide religious worship and instructions for the public at large.
 2. To advance spiritual growth and enlightenment, moral and personal purity among its own members and the people of the public at large.
 3. Provide charitable service for the public at large.
 4. Provide fellowship service for the public at large.
 5. To aid in the spread of the Gospel of Jesus Christ, to the ends of the earth, also, to educate, prepare and ordain Christian men and women for the ministry of the Gospel of Jesus Christ.
- B. This corporation shall have the right to acquire, either by gift or purchase, and to hold, own, sell, mortgage, or encumber in any manner, lease and improve real estate and personal property for itself or others.
- C. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

ARTICLE 3 - PURPOSE (CONT.)

D. Provided, however that the corporation shall not be engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall be use to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay and make payments and distributions in furtherance of its stated purposes.

ARTICLE 4 - ELECTION OF BOARD OF DIRECTORS

The number of directors may be lowered or raised by amendment of the By-Laws, but shall in no case be less than three. Elections will be held every 2 years for the Board of Directors. The Board shall be elected from and by the membership of the church. If any member resigns or leaves, the vacancy will be fill by the remaining board members, a two-third majority vote will be required. Board members may be re-elected to another term. There are no term restrictions. The manner of election shall be according to the Bylaws.

ARTICLE 5 - INITIAL REGISTERED AGENT AND OFFICE

The initial registered agent and the initial registered office, Barbara McMillon-Horne, 2682 Clearbrook Circle, Orlando, Florida 32810.

ARTICLE 6 - INCORPORATORS

ARTICLE 7: OFFICERS

The officers of the Corporation shall consist of a President, Vice President, Secretary, and Treasurer. Other officers may be provided for in the By-Laws. Each officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the By-Laws.

ARTICLE - 8 - NON-STOCK CORPORATION

The Corporation is organized (and shall be operated) on a non-stock basis within the meaning of the Florida Not For Profit Act. And shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the By-Laws.

ARTICLE - 9- AMENDMENTS

Amendments may be made to the Articles of Incorporation, when approved by the church, and must be forwarded to the Secretary of State of Florida to be filed and approved before they become effective.
