ARTICLES OF INCORPORATION

The undersigned, all of whom are citizens of the United States, and all of whom are over the age of eighteen. desiring to form a NonProfit Corporation under the Non-Profit Corporation Law of the State of Florida as outlined in Chapter 617 of the Florida Statutes, do hereby certify:

ARTICLE 1; The name of the Corporation shall be UNITY OF BREVARD, INC.

ARTICLE II: The place in this state where the principal office of the Corporation is to be located at 2175 White Sands Drive in the City of Titusville, Brevard County, Florida. The name of the initial registered agent at such address is Monique Knowles.

ARTICLE III: Said corporation is organized exclusively for education and charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The purposes of this corporation will be to provide dance and thespian activities to children to improve their self-esteem, self worth and discover their individual talents.

ARTICLE IV; The period of duration of this corporation is perpetual, unless dissolved by law. Corporate existence shall commence upon filing these Articles of Incorporation with the Secretary of State, State of Florida.

ARTICLE V1: There shall be no compensation for the Directors of this Corporation and they shall exercise their duties with the care an ordinarily prudent person would exercise under similar circumstances, in a manner he/she reasonably believes to the in the best interests of the Corporation.

ARTICLE V11: The manner in which Directors of this corporation are to be elected or appointed shall be as outlined and contained in the By-Laws of this corporation.

ARTICLE VII1: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III thereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE 1X: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes, within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction o of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
