#### a Non-Profit Corporation

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation.

#### **ARTICLE I**

The name of the Corporation is **SOUTHERN GROVE ESTATES PROPERTY OWNERS ASSOCIATION, INC.** 

#### ARTICLE II

The period of duration of the corporation is perpetual. The principal address is Rt. 1, Box 31-A, Lamont, FL 32336.

This corporation reserves the right to amend or repeal these Articles of Incorporation. The power to adopt, alter, amend, or repeal the Bylaws of this corporation shall be vested exclusively in its Board of Directors.

#### ARTICLE X

In the event of the dissolution of this corporation, after paying or adequately providing for the debts or obligations of this corporation, the directors, or persons in charge of liquidation, shall grant, convey, assign and transfer the remaining assets of this corporation unto:

- 2.) A corporation, trust, or community chest, fund or foundation:
- a.) Created or organized in the United States or in any possession thereof, or under the law of the United States, or any state or territory, the District of Columbia or any possession of the United States;
- b.) Organized and operated exclusively for religious, charitable, scientific, literary or educational purposes, or for the prevention of cruelty to children or

animals;

- c.) No part of the net earnings of which inures to the benefit of any private shareholder or individual; and
- d.) No substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.

The assets transferred to any organization listed above shall be used within the United States, or any of its possessions, exclusively for the purposes specified in subparagraph (b).

No such organization listed above shall qualify for distribution unless such organization shall be an organization, association, fund, or foundation organized and operated exclusively for charitable, religious, scientific or educational purposes which is a tax exempt, non-profit corporation under the United States Bureau of Internal Revenue.

If the corporation holds any assets in trust at the time of dissolution thereof, such assets shall be disposed of in such a manner as may be directed by decree of the Superior Court in the county in which the dissolved corporation had its principal office, upon petition thereof by the Attorney General, or any person concerned in the liquidation.
