ARTICLES OF INCORPORATION  
of  
KEEPERS OF THE SPRING, INC.

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida statutes, adopts the following Articles of Incorporation:

ARTICLE I -Name

The name of the corporation shall be:

Keepers of the Spring, Inc.

ARTICLE II - principal place of business and  
mailing address:

ARTICLE III - Purposes

The specific purposes for which the corporation is organized are:

Section 1                      To assist in manifesting balance, harmony and healing in the lives of our members. This will be done through sharing, instructions, study and ceremony.

Section 2                      To organize, establish and maintain spiritual and healing centers, meeting places and retreats for study, exchanging views and encouraging one another in our spiritual growth and healing.

Section 3                      To train, certify and ordain Ministers, Healers, Teachers and Missionaries.

Section 4                      To function as a spiritual center, healing center, church, school and policy-making organization, striving for the the truths incorporated in our principles and teachings.

Section 5                      The Corporation shall be empowered to publish papers, pamphlets, books and magazines; acquire rent, lease, let, hold, own, buy, convey, mortgage, sell or assign property--real, personal or mixed, as the purpose of this corporation whether expressed or implied, shall require.

Section 6                      The Corporation shall be empowered to do and perform all such other acts and things, including those generally allowed by the laws of the State of Florida relative to corporations not-for-profit, as now existing, or as the law may henceforth provide, as from time to time may be necessary or expedient in the exercise of any or all of its corporate functions, powers and rights.

ARTICLE IV - The qualification for members and the manner of their admission.

The membership of this corporation shall constitute all persons who shall share in the aspirations, objects and purposes of the corporation as stated in Article II, Section 1 through 6, and whose application for membership shall be approved by a majority of the Board of Directors. The manner in which the directors are elected or appointed are contained in the by-laws of Keepers of the Spring.




This corporation is organized under a non-stock basis.
