**Article V**

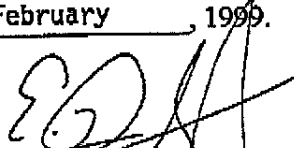
The Corporation has not commenced to conduct its affairs.

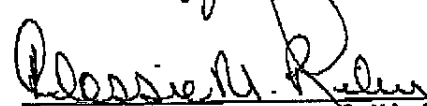

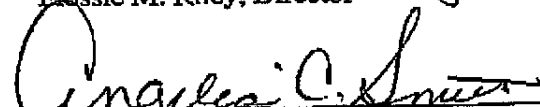
