- (4) TO SOLICIT FUNDS FOR FUTHERANCE OF THE CORPORATE OBJECT AND PURPOSES.
- (5) TO ENTER INTO, MAKE, PERFORM AND CARRY OUT ANY CONTRACTS OR AGREEMENT FOR ANY PURPOSES OR OBJECT HERE IN SET FORTH, WITHOUT LIMIT AS TO AMOUNT, WITH ANY ASSOCIATION OR CORPORATION.
- (6)TO DO ANY ACT SUITABLE AND PROPER INTHE ACCOMPLISHMENTOF THE PURPOSES OR THE FURTHERANCE OF THE POWERS HERE IN SET FORTH: EITHER ALONE OR IN ASSOCIATION WITH OTHER CORPORATION OR INDIVIDUALS OR OTHERWISE.
- (7)TO EXERCISE THE POWERS PERMITTED NON-PROFIT CORPORATIONS UNDER CHAPTER 617, FLORIDA BE AMENDED PROVIDED HOWEVER THATTHE CORPORATION IN EXERCISING ANYONE OR MORE OF SUCH POWERS,
- SHALL DO SO IN FURTHERANCE OF THE EXEMPT PURPOSE FOR WHICH IT HAS BEEN ORGANIZED AS DESCRIBED IN 501(C) OF THE INTERNAL REVENUE CODE. THE FOREGOING PURPOSES AND POWERS ARE EACH AND ALL SUB-
- JECT TO THE LIMITATIONS THAT NO PART OF THE PRINCIPAL OR NET EARNING OF THE CORPORATION SHALL INSURE TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL, THAT NO SUBSTANTIAL PART OF THE PRINCIPAL ACTIVITIES OF THE CORPORATION SHALL CONSIST OF CARRYING ON ANY PROHIBITED ACTIVITIES.
