**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
THE INTERNATIONAL SEAKEEPERS SOCIETY, INC.**

Pursuant to Section 617.1006, Florida Statutes, **THE INTERNATIONAL SEAKEEPERS SOCIETY, INC.** (the "*Corporation*") hereby amends Article II and Paragraph A of Article IV of its Articles of Incorporation and substitutes in its place the following provision:

**ARTICLE II  
NAME AND ADDRESS**

A. The name of the corporation shall continue to be **THE INTERNATIONAL SEAKEEPERS SOCIETY, INC.**

B. The street and the mailing address of the principal office of the *Corporation* shall be 255 Aragon Avenue, Third Floor, Coral Gables, FL 33134.

**ARTICLE IV  
PURPOSES; RESTRICTIONS**

A. Subject to the provisions of this Article, the purposes for which the *Corporation* is organized are to receive and administer real and personal property and to apply such property, as well as the income it produces, exclusively for charitable, scientific, literary and educational purposes, either directly or by contributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 and the corresponding provisions of any subsequent Federal tax laws. In particular, the primary purpose of **THE INTERNATIONAL SEAKEEPERS SOCIETY, INC.** is providing activities that contribute to the development of good character and the educational development of minors through access to hands-on science education for K-12 students.

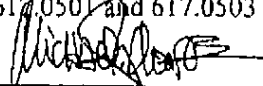
There is no member requirement to amend the Articles of Incorporation. The amendment was approved by a meeting of the directors of the *Corporation*.
