ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE INTERNATIONAL SEAKEEPERS SOCIETY, INC.

Pursuant to Section 617.1006, Florida Statutes, THE INTERNATIONAL SEAKEEPERS SOCIETY, INC. (the "Corporation") hereby amends Article II and Paragraph A of Article IV of its Articles of Incorporation and substitutes in its place the following provision:

ARTICLE II NAME AND ADDRESS

- A. The name of the corporation shall continue to be THE INTERNATIONAL SEAKEEPERS SOCIETY, INC.
- B. The street and the mailing address of the principal office of the Corporation shall be 255 Aragon Avenue, Third Floor, Coral Gables, FL 33134.

ARTICLE IV PURPOSES; RESTRICTIONS

A. There is no member requirement to amend the Articles of Incorporation. The amendment was approved by a meeting of the directors of the Corporation.
