Thereafter, the director will meet at least annually. New directors may be elected on the recommendation of Directors with majority vote of existing directors.

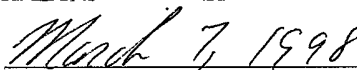

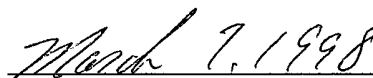
