ARTICLES OF INCORPORATION OF

IGLESIA EL PARAISO CRISTIANO INC.
(The Christian Paradise Church)

Article 1, Name. The name of the corporation is IGLESIA EL PARAISO
CRISTIANO INC. (The Christian Paradise Church Inc.)

Article 2, Duration. The duration of the corporation is perpetual unless
dissolved according to the law.

Article 3, Purpose. The purpose of the corporation is as follows:

This corporation is a non-profit corporation organized
under Chapter 617, Florida Statute. It is not organized for the private gain of any
person. The specific purposes of this corporation are:

A.. To promote the public worship of God, engaging in religious worship or
promoting the spiritual development or well-being of individuals.

B. To spread and propagate the Gospel of the Lord Jesus Christ with
particular emphasis in bilingual and try - ethnic communities and areas.

C. To provide however, that the corporation shall not engage in any
action which is not permitted to be carried on by non-profit corporations under the
Internal Revenue Code and no part of the net earnings of the corporation shall
insure to the benefit of or be distributable to its members, directors, or officers;
but the corporation shall be authorized and empowered to pay reasonable
compensation to these people for services rendered, and to make payments and
distribution in furtherance of its stated purposes.

Article 4, Members. The Corporation shall have voting members, who shall be elected (and may be removed) by the voting members, and who shall have all the rights and privileges of members of the corporation. The By Laws may provide for nonvoting members of one or more classes, who shall be admitted in such a manner and who shall have such rights and privileges as are set forth in the By Laws, but who shall not have the right to vote. Article 6, Initial Board of Directors. The initial Board of Directors shall have five (5), but not less than tree (3) members whose names and addresses are:

Article 7, Initial Principal Office. The initial principal office of the corporation shall be: 165 White Birch, Kissimmee, Fl. 34743.

Article 8, Officers. The officers of the corporation shall consist of a President, Secretary and Treasurer. Other Officers may be provided for in the By Laws. Each officer shall be elected as provided by the By Laws. The name and address of each initial officer of the corporation is as follows:

Article 11, Dissolution. In the event of dissolution, the residual assets of the corporation shall be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (C) (3) and 170 (C) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local government for exclusive purpose.

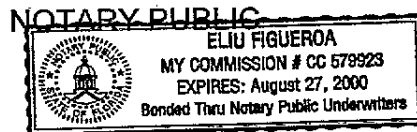
