The undersigned, acting as incorporator of a corporation under Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation:

I. NAME OF CORPORATION:

The name of the corporation is the Jax Area RSD and Chronic Pain Support Group, Inc., a Florida "Not for Profit" Corporation.

VIII. CORPORATE PURPOSES



corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.

6. All of the foregoing purposes shall be exercised exclusively charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 502 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
