The undersigned Incorporator to these Amended Articles of Incorporation, hereby forms a Not for Profit Corporation under the laws of the State of Florida.

ARTICLE I

The name of the Corporation is: The Art For Peace Foundation, Inc.

ARTICLE II

- (a) Said corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code.
- (b) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

(c) Upon dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the internal revenue code, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or state or local government, for a public purpose.
