

ARTICLES OF INCORPORATION



OF

ST. CLOUD SOCCER CLUB, INC.

A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporators pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation shall be ST. CLOUD SOCCER CLUB, INC. The principal address of the corporation at the time of incorporation is 1650 Sundance Drive, St. Cloud, County of Osceola, Florida.

ARTICLE II - DURATION

The duration of this corporation is perpetual unless dissolved according to law.

Corporate existence shall commerce on the date these Articles of Incorporation are filed by the Department of State.

ARTICLE III - PURPOSE

This corporation does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are as follows:

- A. To promote Soccer for the youth of St. Cloud, Florida.
- B. To encourage participation in Soccer by the youth of St. Cloud, Florida, and the surrounding area.
 - C. To promote the sport of soccer in the Central Florida area.
 - D. To equip, improve and maintain the soccer facilities in St. Cloud.

ARTICLE IV - REGISTERED OFFICE AND RESIDENT AGENT

The street address of the corporation's initial registered office is 1650 Sundance Drive, St. Cloud, County of Osceola, Florida and the name of the corporation's initial resident agent is Teresa Everett.

ARTICLE V - NON PAYMENT OF SALARIES

No part of the corporation's income shall be distributed to its directors or officers and the corporation shall not have or issue shares of stock or pay dividends.

ARTICLE VI - QUALIFICATION AND ADMISSION OF MEMBERS

The qualifications for members and the manner of their admission by the corporation shall be as regulated by the corporation's bylaws.

ARTICLE VII - BOARD OF DIRECTORS

The method of election of directors shall be as stated in the bylaws of the corporation.

<u>ARTICLE VIII - BYLAWS</u>

The bylaws of this corporation shall be adopted by the members and may be altered, amended or rescinded in the manner provided in the bylaws.

ARTICLE IX - AMENDMENT OF ARTICLES

Amendments to these Articles may be proposed by a resolution adopted by the board of directors and presented to a quorum of the voting members for their vote.

Amendments may be adopted by a vote of two-thirds (2/3) of a quorum of the voting members of the corporation.
