#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation shall be: LOVE OF THE WOLF, INC.

# ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business of business and the mailing address of this corporation shall be: 4191 Fountain Palm Road, Cocoa, Florida 32926.

## ARTICLE III GENERAL AND SPECIFIC PURPOSES

- (a) The specific purposes for which this corporation is formed are to take in, rehabilitate, care for, and provide homes for unwanted wolves and wolf hybrids, and to educate the public regarding the care and treatment of wolves and wolf hybrids.
- The general purposes for which this corporation is formed are to operate exclusively for such charitable, scientific and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.
- (c) This corporation shall not, as a substantial part of its activities, by propaganda, lobbying, or otherwise, attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

Directors shall be elected or appointed as provided in the bylaws. The initial directors shall be:

#### ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, scientific or educational purposes, which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
