We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Articles of Incorporation:

### **ARTICLE I**

#### **NAME**

The name of this corporation shall be LATTER RAIN CHURCH OF CHRIST APOSTOLIC, INC. and its principal place of business and place of worship shall be at 6385 Royal Tern Street, Orlando, FL 32810, Florida.

### **ARTICLE II**

#### **PURPOSE**

The general purpose of this corporation shall be to conduct religious worship and instruction and maintain churches, schools and other institutions connected therewith of a religious, educational, charitable and benevolent character; to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located; and, to aid in the spread of the Gospel of Jesus Christ. For the purpose of promoting the foregoing objects, this corporation shall have the right to acquire, either by gift or purchase, and to hold, own, sell, mortgage, or encumber in any manner, lease and improve real estate and personal property for itself and others, either as Trustee or otherwise.

This corporation shall have perpetual existence.

### ARTICLE IV

#### QUALIFICATIONS FOR MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the bylaws.

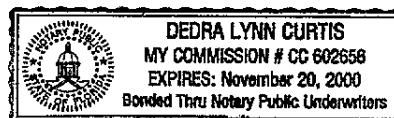
