**ARTICLES OF INCORPORATION
OF
MIAMI DADE BAIL COORDINATORS ASSOCIATION, INC
A CORPORATION NOT FOR PROFIT**

ARTICLE I - NAME

The name of the corporation not for profit shall be MIAMI DADE BAIL COORDINATORS ASSOCIATION, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office, as well as the mailing address of the corporation shall be 1465 NW N. River Drive, Miami, Florida 33125.

ARTICLE III - PURPOSE

The purposes for which the corporation is organized are exclusively for charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The method of electing directors shall be stated in the bylaws of the corporation.

ARTICLE VI - CORPORATE POWERS

There shall be no limitation on the corporate powers listed in Florida statute 617-0302, as amended from time to time.



ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT



ARTICLE IX - CORPORATE ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Internal Revenue Code section 501(c)(3), or corresponding section(s) of any future federal tax code or shall be distributed to the federal government, or a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
