ARTICLES OF INCORPORATION

OF

The undersigned Incorporators, for the purpose of forming a corporation not-for-profit under the authority of Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I - NAME

ARTICLE VIII

Amendment to these Articles may be proposed by any member of the Corporation. These Articles may be amended at any annual meeting of the Corporation, or at any special meeting duly called and held for such purpose, on the affirmative vote of a majority of voting members present in person or by proxy at a lawfully called meeting and by not less than two-thirds (2/3) of the entire Board of Directors.

In the event no such organization may be found, such assets shall be granted, conveyed, and assigned to an appropriate public agency to be used for purposes similar to these for which the Corporation was created.
