ARTICLES of INCORPORATION
for
PENSACOLA AREA FLIGHT WATCH, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be Pensacola Area Flight Watch, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be

8113 Treetop Lane, Pensacola, Florida 32514

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:

- A. To preserve, support, and promote General Aviation within the Greater Pensacola area. The term *General Aviation* in the context of these articles shall be defined as *all civil aviation except air carriers*.
- B. To operate and act exclusively for charitable, educational, scientific or other exempt purposes, and/or to lessen the burdens of government, which may include, but shall not be limited to educating the public regarding aviation in the United States.
- C. To campaign for, receive, hold and apply funds, gifts, bequests and endowments or the proceeds thereof to any of the purposes herein described including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law, (the "Code").
- D. To do all such further acts as are necessary and convenient or expedient to accomplish the foregoing purposes or as are incidental thereto.
- E. Notwithstanding any other provision of these articles, the Pensacola Area Flight Watch shall not carry on any activity not permitted to be carried on (a) by an organization which is described in Section 501 (c)(3) of the Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law and which is exempt from Federal Income Tax under Section 501(a) of the Code or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Code.

F. No substantial part of the activities of Pensacola Area Flight Watch shall be to carry on propaganda or otherwise attempt to influence legislation.

G. The Pensacola Area Flight Watch shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The Board of Directors shall consist of five persons. The initial three directors of the corporation are **Hebert S. Fowler, Dale A. Holbert, and Ronald M. Sodano.**

Other directors shall be elected or appointed in the manner and for the terms provided for in the by-laws. The initial three directors shall serve for six months following the effective date of these articles, or until relieved by directors elected in accordance with the by-laws.

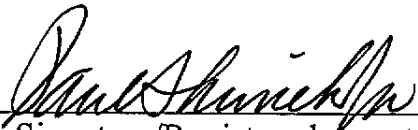

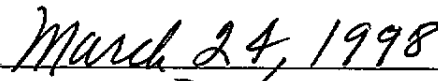
