#### Article III

#### **Purposes**

The specific purposes for which the corporation is organized are:

H.A.P.P.Y. stands for Honest and Patient People Protecting Youth. Our main objectives are as follows:

- I. Bring the community together
- II To strengthen the community
- III. To help citizens to be more knowledgeable of what their communities offer
- IV. To make community programs more easily accessible
- V. To enhance American Morals as written in Declaration of Independence, etc..

### I. To provide the means to bring the community together / Educating community citizens

- A. Providing physical recreation for all people in the community, regardless of sex, race, religion, age, financial status, etc. But more specifically, families.
  - 1. Acquiring property to build a recreational facility on, that can facilitate the needs to do so,
    - a. The facility will be designed according to the community that they are built in, with an eclectic enhancement.
- B. Cleaning up the community.
