ARTICLES OF INCORPORATION
OF
LITTLE ROCK MISSIONARY BAPTIST CHURCH, INC.

The undersigned associate together for the purpose of becoming a church corporation not for profit under Chapter 617, laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I: NAME

The name of this not for profit Church corporation shall be **LITTLE ROCK MISSIONARY BAPTIST CHURCH, INC.**

ARTICLE II: PURPOSE

This not for profit Church corporation is organized exclusively for religious, charitable, scientific, literary and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the successor provision of any future United States Internal Revenue law. To the end that the foregoing objectives and purposes and any related religious and charitable purposes may be carried out, performed and accomplished, this Church corporation shall have the power to engage only in such activities as shall not constitute business unrelated to its religious, benevolent, charitable, literary and educational purposes.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the successor provision of any future United States Internal Revenue law. Subject to the foregoing limitations, this Church corporation shall have all of the rights and powers set forth in section 617.0302, Florida Statutes.

ARTICLE III: PRINCIPAL OFFICE

The street address of the initial principal office is 1418 Van Buren Street, Jacksonville, Florida 32206. The mailing address of **LITTLE ROCK MISSIONARY BAPTIST CHURCH, INC.**, is the same as the street address for the initial principal office.

ARTICLE IV: MEMBERSHIP

The membership of this corporation shall consist of all persons who shall meet the following qualifications for membership and who shall be admitted in the following manner:

1. In order to qualify for membership in this Church, a prospective member must accept, believe in and rely on Jesus Christ for his salvation and give evidence of his intention to keep his commandments; must believe that the Holy Bible is the Word of God; must publicly confess his faith; must commit himself to participate actively in the fellowship of the Church; and must submit himself to the authority of the Pastor, Board of Trustees and the discipline of the Church.

2. The Pastor, after advice and consultation with the existing membership, shall determine whether any applicant for membership meets the foregoing qualifications; and , if so, the applicant shall be admitted to membership in this Church.

ARTICLE IV: INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1418 Van Buren Street, Jacksonville, Florida 32206, and the name of the initial registered agent of this corporation at the address is Reverend Levi White , Jr.

ARTICLE V: DURATION

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are filed.

ARTICLE VI: DIRECTORS

(a) The corporation's directors shall be known as trustees. The method of election of trustees shall be stated in the corporate by-laws.

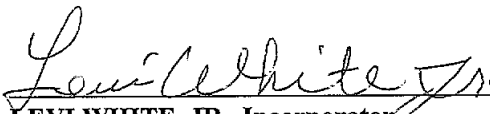
CERTIFICATE OF DESIGNATION

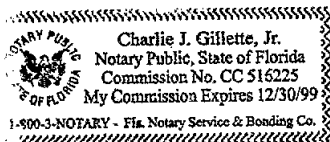
