ARTICLES OF INCORPORATION  
OF  
THE NATIONAL TRAINING AND TECHNICAL ASSISTANCE CENTER, INC.

A Florida Not For Profit Corporation

**ONE:** The name of the corporation is The National Training And Technical Assistance Center, Inc.

**Two:** The address of the initial principal office of the Corporation shall be 645 Creekwood Drive, Orlando Florida 32809.

**Three:** This Corporation is a not for profit public benefit corporation and is not organized for the private gain of any person. The Corporation is organized exclusively for educational, charitable, scientific and literary purposes within the meaning of 501(c)(3) of the Internal Revenue Code of 1986, as now in effect or as may hereafter be amended ( the "Code"). In furtherance thereof, the Corporation may receive property by gift, devise or bequest, invest or reinvest the same, and apply the income and principal thereof, as the Board of Directors may from time to time determine, either directly or through contributions to any charitable organization or organizations, exclusively for educational, charitable, scientific or literary purposes, and engage in any lawful act or activity for which corporations may be organized under the Florida Nonprofit Corporation Act. In furtherance of its corporate purpose, the Corporation shall have all the general powers enumerated in the Florida nonprofit Corporation Act, as now in effect or as may hereafter be amended, together with the power to solicit grants and contributions for such purposes.

**Four:** The Corporation shall have no members.

**Five:** The number of Directors of the Cooperation shall be no less than three (3) nor more than nine (9) with the exact number of directors to be fixed from time to time within such limits, by approval of the Board. The initial number of directors of the Corporation shall be six ( 6).. The method of election of directors to the board of Directors is to be outlined in the by-laws of the Corporation.

**Six:** The name and address in the State of Florida of the Corporation's initial registered agent for service of process is, Mable A. Burgess, 830 Polk Street, Bartow, Florida 33830.

**Seven:** No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation; nor shall the Corporation intervene in any political campaign on behalf of ( or in opposition to ) any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not directly or indirectly carry on any activity which would prevent it from obtaining exemption from Federal income taxation as a corporation described in 501(c) (3) of the Code, or cause it to lose such exempt status, or carry on any activity not permitted to be carried on by a corporation, contributions to which are deductible under 170 ( c)(2)3 of the Code.

**Eight:** The property of the Corporation is irrevocably dedicated to educational, scientific, charitable and literary purposes meeting the requirements for exemption under the Florida Revenue and Taxation Code. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to any director or officer of the Corporation, or any other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the Corporation and to make payments and distributions in furtherance of the purposes set forth in Article Three (3) Hereof.

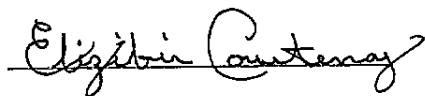
In the event of dissolution or final liquidation of the Corporation, all of the remaining assets and property of the Corporation shall, after paying or making provision for the payment of all of the liabilities and obligations of the Corporation and for necessary expenses thereof, be distributed to such organization or organizations organized and operated exclusively for charitable or educational purposes meeting the requirements for exemption under the Florida Revenue and Taxation Code and as shall at the time qualify as an exempt organization or organizations under 501 (c)(3) of the Code as the Board of Directors shall determine. In no event shall any of such assets or property be distributed to any director or officer, or any private individual.
